ORDER

Cochin Special Economic Zone Authority (CSEZA) is the Licensee for Power Distribution to the Consumers in the Cochin Special Economic Zone.

In terms of Sub-section (5) of the Section 42 of the Electricity Act, 2003 (Central Act 36 of the 2003) which provides for establishment of the Forum for redressal of the grievances of the consumers in accordance with the guidelines as may be specified by the State Commission, CSEZ Authority had constituted a three member Consumer Grievance Redressal Forum vide OrderNo.3/36/2005:Infra:CSEZ/8586 dated 17-09-2008 which was reconstituted on 20-04-2009, 06-08-2010, 01-02-2013 and 18-04-2017.

3. Consequent to the nomination of Shri Jefrin Manuel, Kurisinkal House, Manjummel P.O, Ernakulam as 3rd member of CGRF in place of the earlier member Shri Johny Kuriakose Methippara, Advocate, Muvattupuzha the Consumer Grievance Redressal Forum of CSEZA is hereby re-constituted as below:-
