APPENDIX - I

Following conditions shall be added to the scope of work and the additional cost if any including overhead and profit shall be incorporated in the total cost distributed in man days:

1. The staff and labourers shall be finalized after submission of their ID proof & Photo and personal interview with WAPCOS/CSEZA team.
2. WAPCOS has the right to ask replacement of any labourers due to their misbehaviors or lack of performing duties with a one month notice in writing.
3. WAPCOS has the right to terminate the contract due to lack of performing duties with a one month notice in writing.
4. The labourers working in the said work shall not be allowed to carry out any part time jobs inside the zone, if the same is noticed, shall lead to termination of the contract without any advance notice and lead to further forfeiture of SD.
5. The cost of Uniform for labourers, Transportation of Materials and water inside the Zone, Tools, etc. shall be included in the scope of contractor for performing the duties assigned.
6. Water shall be provided by CSEZA at WTP or any other existing points.
7. Monthly payment to the staff and labourers should be transferred directly to their bank account at SBI CEPZ Branch, Kakkanad, Cochin. The proof of the same should to be submitted within 10th of the each month.
8. The proof of ESI, EPF and other statutory payment of the workers should be submitted within 10th of the each month.
